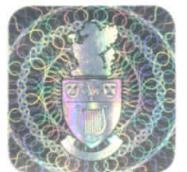

Overall result: **Distinction****Pescetti: Allegro (4th movt from Sonata No. 8 in C)****28/30**

A lively tempo and some vivid dynamic variety gave this a good character. Rarely did the tempo sag and there was much even, lustrous and well-controlled playing of the semiquavers. The left hand supported ably and colourfully, and touch nearly always was clean. It was a confident performance.

Chopin: Mazurka in G minor, Op. 67 No. 2**27/30**

Pedalling gave good sustenance to the well-balanced texture and was timed well. There were one or two slightly less clean and even notes in both hands and one left hand chord was not quite right but the phrasing of the line and the sway of the dance were insightful and engaging. There was good expressivity in the playing.

Martha Mier: Opening Night Jazz (from Jazz, Rags & Blues, Book 5)**26/30**

This had a good upbeat character and the rhythms were shapely as was the phrasing. The right hand missed its location in one bar but good continuity was upheld. Confidence in timing and coverage before the poco rit was a little less assured and there were one or two missed left hand notes. Nevertheless, you conveyed the essence of the music with a fine spirit.

Paul Harvey: Rumba Toccatà**28/30**

The character of both a rumba and a toccata came over in the tempo and playful rhythms and finger work. There were some less even notes but very good attention to the details in the score and reliable accuracy were convincing as was the very assured and committed approach.

Performance as a whole**28/30**

Items were spaced effectively and there was a very good sense of performance as well as some fine musical communication. Interpretations were insightful and mature. Delivery was accomplished for the most part - the moments of unevenness or of slight losses of authority were hardly significant. There was much to savour and to admire in the performances as a whole.
